PROCEDURE FOR HISTORIC LANDMARKS IN KANSAS CITY, NORTH KANSAS CITY
AND JACKSON COUNTY TO EXTEND HOURS BEYOND REGULAR BUSINESS HOURS
(pursuant to section 311.174 RSMo)

ALLOW 10 – 21 DAYS FOR PROCESSING

1. APPLICATION FOR EXTENDED HOURS PERMIT – Completed application for special permit to remain open each day of the week until 6:00 a.m., signed and notarized.
2. LICENSE FEE – Bank Draft, Money Order, Certified Check, or Cashier’s Check, payable to the Director of Revenue, State of Missouri, for correct amount of license fee.
3. CERTIFICATE OF NO TAX DUE – From the Missouri Department of Revenue; must be dated within 90 days and addressed “To Supervisor of Liquor Control.” **Required regardless of exemption status.** Can be obtained [online](#) with the Tax ID and PIN, or by phone at (573) 751-9268.
4. CERTIFICATE OF GOOD STANDING – Corporations and L.L.C.’s must provide a copy of *Certificate of Good Standing* from the Missouri Secretary of State within the preceding 90 days. (Information available at www.sos.mo.gov).

PREQUALIFICATION:

5. In a city with a population of at least four thousand inhabitants which borders the Missouri River and also borders a city with a population of over three hundred thousand inhabitants located in at least three counties, in a city with a population of over three hundred thousand which is located in whole or in part within a first class county having a charter form of government or in a first class county having a charter form of government which contains all or part of a city with a population of over three hundred thousand inhabitants.
6. Entity exempt from federal income taxes under Section 501(c)(7) of the Internal Revenue Code of 1986, as amended.
7. In a building designated as a [National Historic Landmark by the United States Department of the Interior](#).
