Applicant further agrees that he will permit the Supervisor of Alcohol and Tobacco Control and his agents at all times to inspect the licensed premises and every part of the building and plot of ground under his control and upon which the licensed premises are located, and also any place where applicant may have intoxicating liquor stored.

**ALLOW 10 – 21 DAYS FOR PROCESSING**

1. APPLICATION FOR SUNDAY LICENSE – Completed and notarized.
2. PRORATED LICENSE FEE – Cashier’s Check or money order made payable to Missouri Director of Revenue (CANNOT BE COMBINED WITH OTHER LICENSE FEES).
3. CERTIFICATE OF NO TAX DUE – From the Missouri Department of Revenue; must be dated within 90 days. **Required regardless of exemption status.** Can be obtained [online](#) with the Tax ID and PIN, or by phone at (573) 751-9268.
4. CERTIFICATE OF GOOD STANDING – From the Secretary of State, dated within 90 days. *Not applicable to sole proprietors or general partnerships.*
