



ALLOWS ORIGINAL PACKAGE LICENSEES TO CONDUCT TASTINGS ON THE LICENSED PREMISES

RETAILERS HOLDING A TASTING LICENSE CANNOT CHARGE FOR TASTINGS AND CANNOT ADVERTISE FREE TASTINGS.

**ALLOW 10 – 21 DAYS FOR PROCESSING**

1. APPLICATION FOR ORIGINAL PACKAGE TASTING LICENSE – Completed and notarized.
2. LICENSE FEE – Cashier’s check or money order made payable to Missouri Director of Revenue for the corresponding month/fee below. (CANNOT BE COMBINED WITH OTHER LICENSE FEES).
3. CERTIFICATE OF NO TAX DUE – From the Missouri Department of Revenue; must be dated within 90 days. **Required regardless of exemption status.** Can be obtained [online](#) with the Tax ID and PIN, or by phone at (573) 751-9268.
4. CERTIFICATE OF GOOD STANDING – From the Secretary of State, dated within 90 days. *Not applicable to sole proprietors or general partnerships.*
