ALLOW 10 – 21 DAYS FOR PROCESSING

- 1. APPLICATION Completed and signed Application for Off-Site Storage.
- 2. PHOTO Of front of the new building/unit.
- 3. PROPERTY OWNER PERMISSION Copy of the signed lease, deed, rental agreement or other form of property owner permission giving the sole owner, all partners, or legal entity permission to operate at the designated storage location. The document submitted must show the applicant's correct legal name and the physical address of the storage location.
- 4. TTB PERMIT (if applicable) If untaxed liquor is stored off the licensed premises, a bonded warehouse permit from TTB for a non-contiguous location must be submitted with the request for off-site storage for that particular address.
